Changes to the Face Sheet of the CCM Funding Agreement**

Dear Ms. Zetina,

Reference is made to the CCM Funding Agreement SLV-CFUND-2008 between the Global Fund to Fight AIDS, Tuberculosis and Malaria, the CCM El Salvador and Secretaría de la Integración Social de Centroamérica, SISCA (the "CCM Funding Recipient") (as amended from time to time, the "Funding Agreement"). Unless defined in this Implementation Letter or the context otherwise requires, all capitalized terms used in this Implementation Letter shall have the same meaning as set out in the Funding Agreement.

We are writing this Implementation Letter to modify the Face Sheet of the Funding Agreement. Additionally:

1. The Global Fund has approved (a) USD 60,000 in additional funds to support the implementation of the CCM Evolution ("CCM Evolution Activities"); and (b) USD 30,000 in additional funds to support the CCM engagement in the Global Fund's COVID-19 Response Mechanism ("C19RM") funding request development process and implementation oversight ("CCM C19RM Activities"). The new Funding Agreement Amount is USD 450,000. The Costed Workplan have also therefore been updated. If the new CCM Evolution Activities in the updated Costed Workplan are no longer needed or cannot be implemented before 30 June 2023; and/or the new CCM C19RM Activities in the updated Costed Workplan are no longer needed or cannot be implemented as soon as possible, but before the end of the current CCM Funding Agreement or 31 December 2022; the relevant cash balance of the relevant activities will be deducted from the following disbursement decision under the Funding Agreement or requested to be refunded to the Global Fund bank account".
2. Additionally, the Standard Terms and Conditions of the Funding Agreement have been revised to reflect updated data protection requirements.

Pursuant to Section 18.1 of the Standard Terms and Conditions of the Funding Agreement, in order to reflect the above, we are making the following changes to the Funding Agreement:

- A. The Face Sheet in the Funding Agreement is hereby deleted and replaced with the revised Face Sheet annexed to this Implementation Letter;
- B. The Costed Workplan of the Funding Agreement is hereby deleted and replaced with the revised Costed Workplan annexed to this Implementation Letter;

- C. The Performance Framework of the Funding Agreement is hereby deleted and replaced with the revised Performance Framework annexed to this Implementation Letter; and
- D. The Standard Terms and Conditions of the Funding Agreement are hereby deleted and replaced with the revised Standard Terms and Conditions annexed to this Implementation Letter.

Other than as modified by this Implementation Letter, all provisions of the Funding Agreement remain the same.

Please confirm your agreement to the amendments herein by signing this letter and returning a copy to the Global Fund by electronic messaging system.

Thank you for your important efforts [toward health system strengthening and in the global fight against HIV and AIDS, tuberculosis, and malaria. We look forward to the successful continuation of the work of the CCM El Salvador.
